David Melaugh, under penalty of perjury, declares the following:

- 1. I am an attorney duly licensed to practice law in the State of California and an associate in the law firm of Morrison & Foerster LLP, counsel of record for defendant Novell, Inc. ("Novell") in this action. I was admitted to practice before this Court *pro hac vice* by this Court's July 29, 2004 order. I submit this declaration in support of Novell's Motion to Dismiss. The statements made herein are based on my personal knowledge and investigation.
- 2. Attached as Exhibit A hereto is a copy of the complaint filed on March 6, 2003 by SCO in *The SCO Group, Inc. v. Int'l Bus. Machines Corp.*, Case No. 03-CV-0294, United States District Court for the District of Utah. This Exhibit is a true and correct copy of the document obtained from the Court's docket.
- 3. Attached as Exhibit B hereto is a copy of the amended complaint filed on July 22, 2003 by SCO in that suit. This Exhibit is a true and correct copy of the document obtained from the Court's docket.
- 4. On July 28, 2004, I performed a search on LexisNexis's "News, Most Recent Two Years (English, Full Text)" database (CURNWS). I searched for all news articles dated on or after the filing of SCO's suit against IBM (March 7, 2003) including the terms "SCO" and "IBM." The search returned 2,845 results. Attached as Exhibit C is a true and correct copy of the first section of those results, covering the first 50 articles. Neither the full text of the articles nor the full list of results is attached due to their volume.
- 5. I then limited the search described in Paragraph 4 to those articles dated on or after March 7, 2003 and before the date of the first public statement by Novell alleged in SCO's Amended Complaint (May 28, 2003), again including the terms "SCO" and "IBM." The narrowed search returned 317 results. Attached as Exhibit D is a true and correct copy of the first section of those results, covering the first 50 articles. Neither the full text of the articles nor the full list of results is attached due to their volume.
