As I reported in a previous message, I had a problem using the DRDOS setup program with my IBM LAOSX PS2 (notebook), I believe I answered all the questions appropriately. The problem was apparent when I tried to start windows - it locked up on the initial "windows" screen. After many hours of frustating reading I found a solution - I copied MS-DOS 5.0's himem.sys and smartdrv.sys to my disk and NOW USE THAT! Himem has a switch "/M:2" especially for PS2s that has something to do with the "A20 handlo". When using DRDOS's EMM386.SYS I got a warning " Address A20 Already enabled\* that probably was my problem. I would like to use 100% DRDOS, and be able to recommend it. Why do I have to be a memory management fanatic to do this? Is there a simple solution or do I have to reboot my computer 4,234 times to find out? How can I be sure I got it right??!!

DRDOS 6.0 installed easily on an AST 286 with 2M of memory. Virtually all the use of this machine is in a C programming environment running compilers and linkers. Super PC-Kwik is not loaded on startup.

There have been no conflicts or problems. On two occasions I loaded SUPERPCK from the command line prior to running Word Perfect 5.0. WP ran normally for a while then suddenly crashed and the computer warm booted. The active file, which should be periodically written to a temporary file from memory, showed 0 bytes. In other words, all the changes to the files were lost. This only happens when PC-Kwik is loaded. Any clues?

To anyone interested in DRDOS 6.0 who uses petools, a word of advice: JUST SAY NO...don't do it The two products are oil and water on a 286. they will trash your hard drive and make your life a living hell and nary a soul at DR will help you. If you are foolish enough to call them for assistance they will tell you the programs are compatible. They are not. Central Point will at least conced that there is no promise of compatability. DR's lack of interest or attention on the subject of compatability wiith a program whose use is as widespread as potools is, for the makers of what purports to be an alternative to ms dos, negligent and hubristic. Only righteous consumer indignation will pursuade DR to make a modicum of effort to bring their product up to an acceptable level of compatability so if you use petools or ever plan

to and are attracted to some of the hypothetical benefits of drdos, complain, and save yourself an enormous headache by not purchasing the product until it is relatively functional.
