



#### **TERMS & CONDITIONS**

#### Parts & Labor Coverage 3-Year Plan

Throughout this Performance Service Plan ("Plan") the words "we," "us" and "our" refer to Best Buy Co., Inc. in Minnesota and Best Buy Stores,
L.P. in all other states ("Best Buy") and AIG WarrantyGuard, Inc. ("NGWG"). The words "you" and "your" refer to the purchaser of this Plan,

Service and Coverage: To arrange nationwide factory outhorized in-home service on <u>applicable</u> computers and monitors, call 1-800-332-4800. All other Plan repairs, including those on peripherals (scanners, printers) will be performed on a corry-in basis only and must be arranged through a Best Buy store or service center. All preventative maintenance (cleanings, etc.) on applicable products will be handled on a carry-in basis only. Repairs will be performed at our discretion by a Best Buy service center or authorized servicer.

- In some cases you may be required to ship your covered product for repair.
- This Plan covers manufacturer's defects in materials and workmarship that are the result of normal usage.
- Products, including those within the original manufacturer's warranty period, may be repaired or replaced with a comparable product, or Best Buy will issue a voucher for the original purchase price at our discretion.
- Replacement parts will be new, rebuilt or non-original manufacturer's parts that perform to the factory specifications of the product at our option.
- This Plan provides complete power surge protection from the date of purchase on the product covered.
- · All Plan coverage commences on the original product purchase date.
- This Plan is inclusive of the manufacturer's warranty.
- International coverage is available on a limited basis. See store for details.

Purchaser Records: Although we maintain a record of your Plan purchase on a computer remieval system, this validated Plan Certificate and all original receipts are required for any product replacements, exchanges or voucher credits.

No Lamon Policy: After three service repairs have been completed on an individual product and that individual product requires a fourth repair, as determined by us, we will replace it with a product of comparable performance, not to exceed the original products price. <u>Technological advances may result in a replacement product with a lower selling price than the original product. For dearrace, open-box, and other products originally purchased at a discount, we reserve the right to issue a woucher for the original purchase price. The original product and purchase receipts must be returned to Best Buy along with authorized service repair incidents to qualify. One service request number is the equivalent of one repair. <u>Keep your service receipts!</u> Copies of service receipts cannot be provided by us. <u>Preventative maintenance checks, dearrings, product diagnosis, customer education, accessory repairs/replacements, compare software related problems and repairs done outside the U.S.A are not considered repairs for the purposes of the No Lemon Policy. The remaining duration of this Plan will attach to the replacement product under the No Lemon Policy.</u></u>

General Exclusions: This plan does not cover repairs caused by accidental or intentional physical damage, spilled liquids, insect intestation, misuse, abuse or damage caused by non-authorized repair personnel. Also not covered are replacement costs for lost or consumable parts (knobs, remartes, cartridges, drums, etc.) and problems due to improper and/or non-factory authorized installation or repairs.

- Plans are not available or valid for products used for; commercial purposes (multi-user organizations), public rental or communal use in multi-family housing. Use of a product for these purposes will void this Plan, unless noted specifically as a commercial plan on the original purchase receipt.
- This Plan does not cover loss or damage to stored data, repairs related to installed software, computer viruses or computer hardware that is added after the original purchase.
- . This Plan excludes appliances, home and car audio, and video and photo products.
- This Plan does not cover consequential or incidental damages.
- · This Plan does not cover "no problem found" diagnosis.
- This Plan does not cover any malfunction, defect, breakdown, or disruption of any product functions or the function of any related component or software arising from any design flaw caused by, arising from or related to, directly or indirectly any design, planning or engineering incompatibility arrission or deficiency with the incidence of the Year 2000.

Manufacturer's Responsibilities: Parts and services covered during the manufacturer's warranty period are the responsibility of the manufacturer.

Availability of Services: While we try to complete service as quickly as possible, we are not responsible for delays caused by factors beyond our control, including but not limited to manufacturer's delays or acts of God.

Cancellation: This Plan shall be concelled by us for froud or material misrepresentation, including but not limited to commercial or rental use. Unauthorized repair or replacement of covered equipment shall result in the cancellation of this Plan by us. In the event of concellation by us, written notice of cancellation shall be mailed to you not less than sixty (60) days before cancellation is effective. This Plan can be cancelled by you at only time for any reason by mailing or delivering to Best Buy notice of cancellation. If you cancel: (a) within thirty (30) days of the receipt of this Plan, you shall receive a full return of it he price poid for the Plan provided no service has been performed, or (b) after thirty (30) days, you will receive a pro rata returd, less the cost of any service received.

This Performance Service Plan is secured by a contractual liability insurance policy underwritten by New Hampshire Insurance Company, 70 Pine Street, 14th Floor, New York, NY 10270. If, within sixty (60) days from the date proof of loss is properly filed with Best Buy, Best Buy fails to pay a covered claim or to provide a returd, the purchaser or any subsequent holder of this instrument may make a claim directly to the insurer.

Preventative Maintenance Checks:

This Plan includes dearings and/or dignments limited to the following products: facsimile devices.

These maintenance checks are recommended, but not limited to, once a year. All preventative maintenance checks will be performed on a corryin basis.

State Variations: The following state variations shall control if inconsistent with any other terms and conditions

<u>Arizona</u>, <u>Wisconsin & Georgia Residents</u>: Cancellation- If your written notice of cancellation is received prior to the expiration date, the Administrator shall refund the remaining prorated price, regardless of prior service rendered against the agreement.

<u>Arizona Residents:</u> Governing Law- This agreement shall be interpreted and enforced occording to the laws of the state of Arizona.

<u>Arizona & Wisconsim Residents:</u> Emergency- If, in an emergency situation the Administrator connot be reached, the austromer can proceed with repairs. The Administrator shall reimburse the austromer or the repairing facility in accordance with the service agreement provisions.

<u>Tennessee & Maryland Residents:</u> Term Extension. The expiration date of the agreement shall automatically be extended for the duration that the product is withheld from the consumer's use while being repaired, and in Tennessee, two additional working days will be added.

<u>Wisconsin Residents:</u> This warranty is subject to limited regulation by the office of the Commissioner of Insurance.
