The undersigned, acting pursuant to the provisions of the Utah Revised Limited Liability Company Act (as such may be amended from time to time, the "Act"), hereby adopts the following Articles of Organization for the purpose of organizing a Utah limited liability company (the "Company").

- Name.** The Company's name is **DPR MANAGEMENT, LLC**.
- Term.** The Company will continue until December 31, 2109, unless sooner dissolved by law or as provided in the Company's operating agreement.
- Purposes.** The Company is organized for any and all legal and lawful purposes pursuant to the Act.
