- 11. Defendant has actual notice of Plaintiffs' patent rights but Defendant continues to act in a conscious and willful disregard of those rights.
- 12. Defendant's infringement of Plaintiffs' patent rights has irreparably damaged Plaintiffs and will continue to cause irreparable harm unless enjoined by the Court.

### WHEREFORE, Plaintiffs ask this Court to:
